

NOTICE OF A HEARING ON

PROPOSED RATES AND CHARGES

Ratepayers and other interested parties in or served or to be served by the waterworks of And-Tro Water Authority are hereby notified that a Resolution establishing rates and charges for use of water supplied by the waterworks of said Water Authority was introduced at a meeting of the Water Authority held on the 8th day of January 2024. At a meeting of the Board of Directors of the And-Tro Water Authority to be held at 10:00 a.m. on the 12th day of February 2024, in the office of And-Tro Water Authority which is located at 14100 Old State Road 37, Tell City, Indiana, there will be a public hearing on the matter of the rates and charges, and consideration of adoption of said Resolution 2024-1-08 which provides in part as follows:

Section 2.

There shall be established the following additional charges:

Deposit Fee

A Refundable Deposit Fee of one hundred dollars (\$100.00) shall be paid per membership customer.

Reconnection Fee

A Reconnection Fee of one hundred dollars (\$100.00) will be charged when service has been turned off for any reason. A change of occupancy, or Transfer Fee, is also included in this charge. The reconnection shall be scheduled during normal working hours of operation.

Tap-In Fee

The Tap-in Fee of one thousand three hundred dollars (\$1,300.00) for a 5/8" or a ¾", plus \$800 if a road bore is required, or the actual cost of installation for all meters, in no event less than one thousand three hundred dollars (\$1,300.00), shall be made for each new meter installation regardless of location. This tap-in fee is in addition to the Deposit fee set forth herein. Each meter requires a separate meter reading sheet, and each meter reading sheet will cover a separate and individual account.

Return Check Fee

When a customer's check is returned unpaid by the bank for any reason (not the fault of And-Tro Water Authority) the customers shall be assessed a handling charge of twenty-five dollars (\$25.00) for each check returned. If two (2) unpaid checks are received within a one (1) year period the customer will then have to pay in cash or money order. The customer may bring a notice from the customer's bank showing good credit and checks can be received from thereafter.

Late Payment Charge

Non-payment after the 17th of the month will be subject to a penalty of ten (10%) percent of the past due balance.

Special Meter Readings

The Authority will make special meter readings at the request of the customer for a fee of one hundred dollars (\$100.00), provided, however, that if such special reading discloses that the meter was over-read, no charge will be made.

Temporary Users

Water furnished to temporary users such as contractors, circuses, etc., shall be charged on the basis of the metered gallons rates herein before set forth as estimated and established by the Waterworks Superintendent.

Rental Property

The Property Owner must keep the deposit in their name and not the renter. Property Owners will have their name and in c/o the renter if requested by Property Owner.

Purchase Water Adjustment

A rate adjustment in addition to the rates herein set forth for the use of water supplied by And-Tro shall be made on the basis of a purchased water adjustment tracking factor occasioned solely by changes in the cost of the water purchased by And-Tro from its suppliers of water, which cost adjustment shall be the same as most recently billed to And-Tro by its suppliers of water which shall be made as changes in the cost of water purchased from its suppliers by And-Tro are changed, adjusted for a water loss factor between amount of water purchased and the amount it water sold commencing with the next billing cycle of And-Tro.

Effective Date

This resolution shall be in full force and effect from and after its passage and adoption.
